1	Independent 3rd Party for M&V - Does the University expect the ESCO to propose their own independent 3rd parties to perform M&V? Typically, ESCO's self-perform M&V and independent 3rd parties oversee that process on your behalf, under contract to the Owner. Owners hire a 3rd party independent M&V engineer and their services should include negotiating an M&V plan (during the IGA), witnessing of M&V activities (during & after construction), and reviewing M&V reports quarterly, semi-annually, and/or annually as needed. In CT, this service was historically provided by Technical Services Providers (TSPs) in the old DEEP Lead By Example Process: https://portal.ct.gov/DEEP/Energy/Lead-By-Example/Energy-Savings-Performance-Contracting-Program We understand you are mirroring the DOE FEMP Process now. 9	Can construction activities completed more than 10 years ago but the project is still in the annual services phase be used as a previous relevant experience or must the construction phase be within the last 10 years?	Construction phase must be within the last ten years
10	In order to accelerate your procurement process and avoid disruption to the educational environment, would the University of Connecticut consider limiting the Second Part of the solicitation process referred to as the Investment Grade Technical Energy Audit to a subset of buildings that is representative of the unique building types of the UCONN campus rather than all those identified in "Table 1 – Building List for ESPC RCx" on page 3?	The university needs to understand the entire scope of work and financial obligation. The IGA will be completed over summer with minimal disruption to educational environments.
